## **TAXI TERMS AND CONDITIONS**

### **1. General**

The transport of students to and from the school is a service we provide for the iDSB. The Taxi service that the school organizes is organized by the taxi company it self. The taxicompany will provide the necessary informations on the routes and pick-up time. We would like that the children our ready at the door on the resquested pick-up time. (which will be provide to you 1 week before the start of the contract. The school wants that the children will arrive at 7u50. On weekdays the taxi will leave at 15u40 and on Wednesdays the taxi will leave at 13u10.

Taxi service is not responsible for damage to clothing, valuables etc. Parents are responsible for damages on purpose.

The minimum age for the schooltransport is 6 year. Exception is made when the younger child is accompanied by a brother or sister who is older than 6. This is at the responsibility of the older brother or sister.

### **2. Subscriptions**

The taxiservice works with subscriptions for a year, or subscriptions for a month.

The subscription begins on the first schoolday and is due for 1 year or 1 month. It can be suspended with a notice of three months. At the end of the schoolyear the subscription are automatically suspended.

Exception on this rule is when a student is expelled from the school. When it hold a year contract which is payed already, the difference will be payed back to the parents.

### **3. Taxiprices**

The rates will be fixed together with the board of the iDSB and will be notified on the website of Taxi Walter Zaventem and on the website of iDSB.

The yearly subscriptions will be billed once in the beginning of the school year when the employer pays this.

When the parents have to pay the invoice. The invoice will be send monthly with a caution of one month.

### **4. At the pick-up place**

The students must be ready at the door 5 minutes before the departure time.

## **5. Transport ID**

Upon completion of the contract, monthly or yearly there will be a transport ID provided for the duration of the contract, the students is supposed to have this with them at all time of the transport.

## **6. During the drive tot the school**

Because of security regulations everybody must be calm in the bus, and wear safetybelts. Everybody remains on their seat during the trip to school. We all keep the bus clean and will not demolish anything on purpose.

It is forbidden to eat, drink, write, being noisy and smoke.....

Every students must listen to he taxidriver. Who repeatedly disobeys may be suspended from the bus.

## **7. Drop off point at the school**

When we arrive at the iDSB school, everybody goes his own way on his own responsibility. Without any guidance to his own class.

The students who will have to cross the street have to use the crossway with the traffic lights.

If there are students who are for some reason not taking the return bus please announce this to the driver.
